**Background**

Agriculture development programmes implementation involves huge costs of investment, resources and time. Many atimes outcomes are not satisfactory due to inherent challenges and complexity of technical programme. Evaluation can provide feedback on factors affecting and at same time be influential in bringing change. A comprehensive plan of action of monitoring, evaluation and impact assessment encourages learning and improvement in outcomes of the programmes is necessary. It helps the programme implementing agency in reorientation, reassessment and refinement of technologies and programmes for effective future planning. Understanding the concepts, principles and procedures of evaluation is most important skill necessary for facilitators of M & E and training programme in designed with the objectives.

**Objectives**

To identify the important concepts and components of monitoring, evaluation and impact assessment of rainfed development programmes.

To acquaint with commonly used designs, methods, approaches, indicators and data collection methods in monitoring, evaluation and impact assessment of NRM programmes and technologies.

To understand how to interpret and communicate results from monitoring, evaluation and impact assessment in order to ensure their use in programme planning and implementation.

**Methodology**

The course will consist of in-house lectures, field demonstrations/ practicals, hands on training, interactive discussions in a participatory mode and exposure visits.

**Course Content**

The course content will be deal with concepts, purpose, role of monitoring evaluation and impact assessment design, theory of change evaluation matrix, evaluation methods, indicators, statistical tools, softwares and practical exercises on impact assessment of watershed development programmes, agriculture development programmes etc.,

**Faculty**

The scientists of CRIDA would be the resource persons for the training course in addition to a few selected experts of evaluation from other ICAR institutes, State Agricultural Universities, International Organizations etc.

**Duration**

The duration is 10 days i.e., from November 1-10, 2017. Participants are expected to **arrive latest by October 31<sup>st</sup> evening** and can leave CRIDA on **10<sup>th</sup> November after 1700 hrs.**

## Eligibility

- M.Sc./ Ph.D in Agriculture & allied Sciences/ Agriculture Extension/ Home science Extension & Veterinary Extension.
- Working not below the rank of Assistant Professor/ Scientist or equivalent in the State Agricultural university/ICAR. Institute.
- The number of participants for the programme will be limited to 25 on first come first serve basis.

## Nomination & Course fee

There is no Course fee, however a non-refundable registration fee of Rs. 50/- (Rupees Fifty only) is to be remitted through Uncrossed Postal Order drawn in favour of Director, CRIDA payable at Saidabad Post Office, Hyderabad.

## Travelling Allowance

Participants will be paid to and fro fare for journey performed by the shortest route by rail or bus or other means of transport. The payment will be made as per their entitlement but restricted to **maximum of AC II tier train fare only**. If any participant chooses to travel by Air, he/she may do so, but their **claim shall be restricted to AC II tier train fare**, provided they travel by Air India and book the tickets with **ICAR code (095)**.

Lodging and boarding facilities will be provided free of cost to the participants at CRIDA campus.
